Dear Colleagues,


Come on spring! As we are starting to see the COVID positivity rates and hospitalizations decline across the country, there may be a little relief afoot. I want to thank and continue to encourage all my EM colleagues. Many of us will have long lasting scars from the last 2- years but there is a possibility that the worst is behind us.

Maryland ACEP continues to work hard for our members and keep you abreast of key issues impacting our specialty. As you may know, for the second year our legislative reception at the Red, Red, Wine Bar in Annapolis was cancelled due to COVID-19. Historically we would discuss pertinent issues with our legislators. If we are lucky, we will be able to hold this fantastic in-person event next year. In lieu of this, we will hold virtual legislative advocacy sessions with key legislators. This was very successful last year.

A key victory for Maryland ACEP this winter was our effectiveness in raising the awareness of a recent decision by Optum (Maryland's Behavioral Health Administrative Service Organization) to deny payments for Emergency Department professional claims with a behavioral or mental health diagnosis, unless the treating physicians were certified in behavioral health. Optum was denying payments citing that the ED physician was not certified as a mental health provider. Maryland ACEP raised this issue to the Maryland Department of Health, and we were able to have this reversed. Optum will now reprocess claims that were previously denied if the denial was solely because the treating clinician in the ED was not certified in behavioral health.

Our major focus currently is on our Educational Conference on Thursday, April 21st. We are hoping to see you there in-person or virtually. There will be more information regarding the conference along with some great content in this edition. Be well friends.

The 2022 General Assembly began on January 12, 2022. Given the surge in COVID-19 cases, the General Assembly will once again begin in a virtual mode. Currently, the Senate plans to return to a modified in-person mode around February 14th, depending on health metrics. Unfortunately, due to the virtual format and the uncertainty moving forward, MDACEP cancelled its annual Legislative Reception at Red, Red Wine Bar for the second year. MDACEP will be working with members to schedule meetings (i.e., virtual meetings) with legislators, like last Session.

In addition, to once again being virtual, this Session is unique in that the General Assembly will be discussing the redistricting maps for the State, an exercise that occurs once every 10-years, as well as preparing for re-election. Many veteran legislators, such as Chair Shane Pendergrass (House Health and Government Operations), Chair Maggie McIntosh (House Appropriations) and Chair Delores Kelley (Senate Finance) have announced their retirements after this Session, setting the stage for new leadership announcements for the 2023 Session. Besides redistricting, other hot topics will be the legalization of recreational cannabis, the use of the projected 2023 budget surplus and climate change. As usual, MDACEP leadership will continue its efforts to review any legislation introduced that affects the practice of emergency medicine.
