News Legislative & Public Policy Committee

The 2023 Maryland General Assembly Session began on January 11th and is in full swing. MDACEP holds weekly legislative meetings on Mondays to review and discuss bills introduced in the session.



The second week of Session is when Governor Moore took the oath and began building his cabinet. Dr. Laura Herrera Scott is the new Maryland Secretary of Health. Dr. Herrera Scott "served as a vice president at Anthem Blue Cross and Blue Shield, held the position of medical director of population and community health at Johns Hopkins Healthcare and served as deputy secretary of public health under former Gov. Martin O'Malley" (WYPR, Jan 12, 2023). You can learn more about Dr. Herrera Scott here.

MDACEP had a robust attendance and a successful annual Legislative Day in Annapolis on Thursday, January 26th at the Red, Red Wine Bar. Members that attended stated that they not only had an enjoyable time but were also able to hold valuable one-on-one conversations with legislators to help educate them about the needs and concerns of emergency medicine physicians and patients.

The week of March 12th marks the week before "cross-over," meaning that all bills must be voted out of committee by the end of the week to allow adequate time to be read across to the opposite chamber. As such, the committees will be holding subcommittees, hearings, and voting schedule throughout the week.

Important bills that MD ACEP is following:

The bills regarding expansion of scope and revisions of duties regarding physician assistants have been heard in the House Health and Government Operations Committee and were heard earlier this week in the Senate Finance Committee -

Senate Bill 673/House Bill 727: Physician Assistants – Revisions (Physician Assistant Modernization Act of 2023)

Discussions continue between physicians and the physician assistants, but no agreements have been made.

House Bill 274/Senate Bill 387 Task Force on ED Wait Times

This bill convenes a Task Force to study and make recommendations (with

specificity) on how to address ED wait times. Several news articles have cited Maryland as having the worse wait times in the country. MDACEP along with MIEMMS and MedChi have worked on the bill to refine the composition and the charge.

House Bill 811 Hospitals - Overdoses - Testing for Fentanyl

At this time, this bill has passed the House of Delegates. The bill states that, if an individual is treated at a hospital and the hospital conducts a urine drug screening to assist in diagnosing the individual's condition, the hospital shall include testing for fentanyl in the individual's urine drug screening. If the urine drug screening detects fentanyl, the hospital must report the test results, which shall be deidentified, to the Department through CRISP. This does not apply to a hospital that does not have the chemical analyzer equipment.


Attendees will learn from a great mix of nationally known speakers like Rich Cantor and Michael Gravnosky, as well as several regional speakers from all around our state.



The American College of Emergency Physicians' QI Challenge recognizes and spotlights quality improvement and patient safety projects within emergency medicine, especially projects that address disparities in care, focus on ACEP's Choosing Wisely recommendations, and those led by medical students, residents, and fellows. Submission deadline is May 31.

National ACEP especially welcome applications for QI Projects within the following domains:

- 1. Addressing Disparities in Care especially those efforts to improve behavioral health care in the ED
- 2. Projects that focus on ACEP's Choosing Wisely recommendations
- Projects led by trainees (including medical students, residents, and fellows)

Projects will be judged on their overall impact, relevance to one of the three above categories, and improvement science methodology. Projects must be completed within the last 2-years. Award recipients will be chosen from each of the three domains listed above, for a total of 3-winners! Recipients will receive recognition at ACEP Scientific Assembly 2023, publication in ACEP Now and QIPS Newsletter, and recognition through ACEP's communication channels.
