He finished his BSN in 2020, graduating Magna Cum Laude from the University of Maryland. He hit the ground running and hasn't stopped! He quickly obtained his CEN certification, and has already been promoted to SCN I.

Clinically, he's amongst the very best. Be it at the bedside, in triage, as a preceptor, floating as a resource dropping US IVs, training others as a superuser, running the department as charge, or serving as Team Lead for the ED Transport Team - he's on top of it all! He's received multiple hospital "Good Catch Awards," including one for recognizing and intervening on a patient that experienced sudden cardiac arrest.
